The reservation form is available on our website: <a href="www.wfmd.co">www.wfmd.co</a>. There is a \$50.00 deposit which is refundable if the pavilion is left trash free and in good condition.

Adams County Code Compliance is responsible for investigating potential violations in unincorporated Adams County. This includes overgrown weeds, trash and junk around residences as well as inoperable vehicles parked on streets. Vehicles in excess of 7,000 lbs. cannot be kept in residential areas. No boat, trailer, stock car, motor home, camper or construction vehicle shall be parked on any public right-of-way for more than 24 hours.

If your street has a streetlight that is not working properly, call United Power at 303-637-1300. Please have the pole number ready. The pole number is a nine-digit number located on bright yellow tape about eye level on the pole. The lights may take up to three weeks to be repaired.
